TP AFFILIATION SUB-COMMITTEE MEETING.

On 17th July 2015, TP Affiliation Sub-Committee comprising of Offg CEO, Master Trainer, Principal TD and Jasbir Wasu held its meeting at SSSDC. Manager Entp was special invitee to the meeting of the Sub-Committee. Chairman, Kunwar Vikram Singh was in attendance. 3 TPs were approved viz., ADOS Security Pvt Ltd (Dehradun), Saltlake Institute of Engineering & Management Ltd (Kolkata) and Premiershield Pvt Ltd (Delhi). TP's affiliation approval process henceforth will be routed through Affiliation Sub-Committee. Further, the Sub-Committee will meet on every last Wednesday of the month.

MSDE AND UKIERI WORKSHOP.

On 17th July 2015, Col U S Rathore, Principal S&QA attended a day-long workshop on "Developing a Framework for UK-India Collaboration on Skill Development" in New Delhi. The event was jointly organised by Ministry of Skill Development and Entrepreneurship (MSDE) and UK-India Education and Research Initiative (UKIERI).

Shri Pawan Agarwal, Joint Secretary, MSDE, Mr. Rob Lynes, Director British Council India, Ms Malyaj Varmani, Head UKIERI and Ms Claire Irvine from British High Commission were actively involved in the event.

It was stressed upon by various speakers that India, having embraced NOS, NSQF and vocational training should now move fast on the path of skill development to meet its target of skilling 300 million people.

Towards this end, speakers pointed out that training and skilling capacity and quality of Indian institutes is not in sync with world standards. Indian sector skill councils should therefore look for tie ups with foreign sector skill councils for curriculum development, training, assessment, certification and international compatibility of certification.

Speakers pointed out that in UK National Skills Academies for frontier technology sectors such as oil & gas, tunnelling, high speed rails, atomic power, automation, animation & gaming, etc. have been established. These skill academies are called as Community Colleges in the United States.

Speakers also pointed out that our Industrial Training Institutes are in dire need of upgradation both in terms of infrastructure and curriculum so that the trainees receive training as per world standards.

SSCS MEETING WITH MPs.

On 27th & 28th July 2015, Maj Gen Kuldip Singh, Offg CEO attended a meeting on PMKVY at the Parliament House Annexe, New Delhi. The aim of the meeting was to introduce PMKVY and other skilling initiatives to all Members of Parliament by MSDE.

The meeting was chaired by Hon'ble Minister Shri Rajiv Pratap Rudy, MOS(IC) MSDE. Representatives from MSDE, NSDA, NSDC, and all Skill Councils attended the meeting. The meeting on PMKVY continued for consecutive three days, where MPs from all states were informed on the various initiative of Skill India.
